To transfer your cash ISA to Leeds Building Society please follow these steps:

- Step 1: Check what ID you need to provide. Please refer to the General Conditions, Important Information section for details.
- **Step 2:** Complete this Cash ISA Transfer Authority Form and a Cash ISA Application Form (if required, i.e. you are a new customer to the Society and/or are opening a new cash ISA to transfer funds into or you have not subscribed to your existing cash ISA with the Society in the current tax year).
- **Step 3:** Take all required documents to your local branch or send to:

Transfer authority

Transfer acceptance

- The transfer proceeds are made up of cash deposits only.

For the purposes of the transfer of the ISA wrapper under the ISA regulations, the transfer date shall be the date we receive the funds.
